Below you will find two independent sections:

- Participation Guidelines: everything you need to register, produce, and submit your short film.
- Legal Terms: information regarding rights, responsibilities, and technical screening requirements.

Please read both sections carefully: registration implies full acceptance of all content.

1. PARTICIPATION GUIDELINES

1.1 What is the purpose of the contest?

We want to provide a platform for RCD Mallorca fans who are passionate about filmmaking, promoting audiovisual creativity around sports, the island of Mallorca, and the environment — all connected to Real Club Deportivo Mallorca.

This is a social and participatory initiative, not a professional section, aiming to encourage free expression accessible to all audiences.

1.2 Who can participate?

The contest is open to any individual or group. We welcome all RCD Mallorca fans who love cinema to participate, regardless of technical resources or experience.

If the short film's main creator is a minor, written consent signed by a parent or legal guardian is required.

1.3 Registration Information

- Free of charge (no submission fee).
- Submit your short film and the entry form (available on the festival's website) before the deadline stated in the official call.

1.4 What are the requirements for my short film?

| Requirement | Details |
|-----------------|---|
| Duration | 2-5 minutes (including credits). |
| File Format | HD. QuickTime (.mov) or MP4 (.mp4). Horizontal 16:9. |
| Language | Catalan, Spanish or English. If in another language, subtitles in Spanish or Catalan (choose one) must be included. |
| Final Subtitles | If selected as a finalist, an .srt file in Spanish or Catalan (choose one) must be provided. |
| RCDM Element | At least one club-related element must appear (badge, ball, Dimonió, stadium, or other official symbol). |
| Theme | “Sport, Society and Environment.” |

1.5 What will be evaluated in the submissions?

- Originality and storytelling.
- Thematic clarity and value transmission.
- Creativity in integrating the connection with the club and the island.
- Technical quality (image, sound, editing).

1.6 How does the selection process work, and what prizes are available?

The contest’s organizing committee, composed of EMIFF and RCD Mallorca members, will select 20 finalists.

Then, a jury appointed by both entities will decide the winners. The following prizes will be awarded:

- First Prize
- Second and Third Prize
- Audience Award, based on “likes” on a finalist playlist published on the RCD Mallorca YouTube channel.

1.7 Prizes

| Category | Prize |
|-----------------------|---|
| First Prize | €1,000 (invoiced) + premium experience for 2 people (excluding matches against FC Barcelona and Real Madrid). |
| Second & Third Prize | Premium experience for 2 people (excluding matches against FC Barcelona and Real Madrid). |
| Audience Award Winner | Personalized official RCD Mallorca jersey. |

Special Screening:

All finalist short films will be screened during the *Evolution Mallorca International Film Festival* in a special event held at the Estadi Mallorca Son Moix, between **October 21 and 29, 2025**.

1.8 Timeline (reference)

- Submission deadline — September 15
- Finalists announcement (via email) — September 30
- Screening and awards ceremony — between October 21 and 29, as part of EMIFF

2. LEGAL TERMS

2.1 Acceptance and Compliance

By submitting a short film, the participant:

- Confirms having read and fully accepted these guidelines and legal terms.
- Agrees to comply with EMIFF rules; failure to comply may result in disqualification.

2.2 Reproduction and Promotional Rights

The 20 finalist works grant RCD Mallorca and EMIFF non-exclusive rights for reproduction and public communication via social media, corporate websites, press releases, and festival events for 12 months following the edition they participate in.

Award-winning films must include the RCD Mallorca badge in the final master's credits.

2.3 Exhibición y formato

If the work is selected for official programming:

- It must be submitted 3 weeks before October 21.
- High-resolution digital format (.mov or .mp4).
- The following must be provided:
 - Clean version (no subtitles).
 - Subtitled version (if applicable).
 - .srt subtitle file in Spanish or Catalan (only one language).

2.4 Waivers and Limitation of Liability

Participants release the organization, its staff, and volunteers from any liability arising from participation or screening.

No screening fees will be paid.

No refunds or claims will be accepted for damages if the short cannot be screened due to technical issues, operational problems, rescheduling, or delays.

The festival does not cover travel or accommodation expenses.

2.5 Intellectual Property

The person registering the work guarantees they hold all necessary rights (image, music, script, performance, etc.) and shall hold the organization harmless from any third-party claims.

2.6 Applicable Law

Local, regional, national, and European laws and regulations apply.
